



## NOTICE OF PUBLIC HEARING

### City of Oxnard Groundwater Replenishment Reuse Project

**Location:** City of Oxnard, Council Chambers, 305 West Third Street, Oxnard, CA

The public is invited to attend a public hearing on the City of Oxnard's Groundwater Replenishment Reuse Project (GRRP). The hearing is being held in accordance with Title 22, Division 4, Chapter 3, §60320.202 of the California Code of Regulations (Title 22).

**Project:** The City's overall GRRP consist of a number of ASR and recharge wells being located throughout the City, namely at Campus Park, the co-located Blending Stations 1 and 6, Blending Station 3, and River Ridge Golf Course. The Phase 1 ASR Demonstration Well Project is a groundwater recharge and replenishment project using advanced treated recycled water that consists of new treated water conveyance and injection/recovery well facilities. The GRRP Project would use advanced treated recycled water from the Advanced Water Purification Facility (AWPF) to assist the region in reducing its reliance on imported water and to retain water supplies higher in the watershed for regional benefit, including recharge of the groundwater basin. The AWPF was dedicated in 2012 as part of the City's Groundwater Recovery Enhancement and Treatment (GREAT) Program. The AWPF already produces advanced treated recycled water quality that meets groundwater recharge and replenishment requirements, however to date it has only been used for non-potable irrigation and commercial purposes (Title 22 quality for unrestricted use). Though the City currently meets water demand requirements, projections made in the Public Works Integrated Master Plan indicate a potential supply gap throughout the planning period (i.e.: thru 2040). This supply gap, which is based solely on quantity, is projected to be between 3,800 and 10,700 acre-feet per year. These numbers depend on the groundwater pumping restrictions, which are expected to be between 50 and 75 percent less than current rates in the long term.
