NOTICE OF 30-DAY PUBLIC REVIEW OF THE  
2019-20 ANNUAL ACTION PLAN (AAP)**

NOTICE IS HEREBY GIVEN that the City of Oxnard City Council (Council) will conduct a public hearing to receive comments from the public concerning needs of the low to moderate income residents of the City of Oxnard, to present FY2019-20 AAP programs applied for funding by U.S. Department of Housing and Urban Development (HUD) Entitlement Grant programs, and to award programs on **Tuesday, June 4, 2019, at 6:00 p.m., or as soon thereafter as the matter may be heard, in the City Council Chambers, 305 West Third Street, Oxnard, California.**

The publication of this notice is the beginning of the 30-day public review period required by the Citizen Participation Plan and 24 CFR 91.105(b) (2). The public review and written comment period **begins on May 2, 2019, and concludes on June 4, 2019.**

The Council will consider authorizing the City Manager or his designee to electronically submit the 2019 AAP to the U.S. Department of Housing and Urban Development (HUD) *on or before June 12, 2019*, or as required by HUD.

**BACKGROUND**

Each year, the City has participated in entitlement grant programs funded by HUD: The Community Development Block Grant (CDBG), HOME Investment Partnerships Act (HOME), and HEARTH Emergency Solutions Grant (HESG) Programs.

On April 15, 2019, HUD noticed City of Oxnard of allocations for Plan Year 2019 entitlement grants:
