2. The paragraph TRADE NAMES OR EQUALS on page NIB2 of the Notice Inviting Bids shall be deleted in its entirety and is hereby replaced with the following:

"TRADE NAMES OR EQUALS. Tesco Controls, Inc., Carmanah, Cooper Lighting, Emtrac Systems, and McCain Traffic Supply items must be used on the Project as detailed in the Special Provisions because they are needed in order to match other products in use on this particular public improvement. Other than Tesco Controls, Inc., Carmanah, Cooper Lighting, Emtrac systems and McCain Traffic Supply items, Contractor may submit requests to substitute an equivalent material, product, thing or service must be made by written request submitted no later than fifteen (15) Calendar Days following the award of Contract. Requests received after this time shall not be considered. Requests must clearly describe the product for which approval is requested, including all data necessary to demonstrate acceptability."

3. The first paragraph of General Provisions Section 4-1.6 Trade Names or Equals shall be deleted in its entirety and hereby replaced with the following:

"For convenience in designation on the Plans and Specifications, certain materials, products, things, or services incorporated in the Work may be designated under a brand or trade name. As mentioned in the Notice Inviting Bids, Tesco Controls, Inc., Carmanah, Cooper Lighting, Emtrac Systems and McCain Traffic Supply items must be used on the Project as detailed in the Special Provisions because they are needed in order to match other products in use on this particular public improvement. Other than using Tesco Controls, Inc., Carmanah, Cooper Lighting, Emtrac systems and McCain Traffic Supply items, the use of alternative materials, products, things, or services that are of equal quality and of the required characteristics for the purpose intended will be allowed, subject to the approval of the Project Engineer, in accordance with Public Contract Code Section 3400 and Greenbook Section 4-1.6. Unless otherwise stated in writing, the phrase "or equal" shall be assumed after any and all brand and trade names."

4. The detail on page 10 of the plans referencing Carmanah R920-F Dual Sided Rectangular Rapid Flashing Beacon (RRFB) shall be changed to be **R920-E**. All references to R920-F shall be deleted and replaced with **R920-E**. The R920-F is not to be used on this project.
