## CITY OF OXNARD NOTICE OF 2nd PUBLIC HEARING CONSOLIDATED PLAN, 2020 ANNUAL ACTION PLAN and ANALYSIS OF IMPEDIMENTS TO FAIR HOUSING CHOICE

## June 16, 2020 at 6:00 or Thereafter

NOTICE IS HEREBY GIVEN that the City of Oxnard City Council (Council) will conduct a public hearing on Tuesday, June 16, 2020 at 6:00 p.m., or as soon thereafter as the matter may be heard, in the City Council Chambers, 305 West Third Street, Oxnard, California. The purpose of the hearing is to receive public comments on the final draft 2020-2024 Ventura County Regional Consolidated Plan, the final draft 2020 Ventura County Analysis of Impediments to Fair Housing Choice and the 2020 Annual Action Plan, prior to seeking final approval by the City of Oxnard City Council. The beginning of the 30-day public review and written comment period begins on May 15, 2020, and concludes on June 16, 2020.

The U.S. Dept. of Housing and Urban Development (HUD) requires communities that receive annual HUD Entitlement Grants from the Office of Community Planning and Development (CPD) programs; Community Development Block Grant (CDBG), HOME Investment Partnership Act (HOME) and the Hearth Emergency Solutions Grant (HESG), must submit a consolidated plan and annual action plan for approval from HUD before grants funds are released for the Plan year 2020, beginning on July 1, 2020. The five year Ventura County Regional Consolidated Plan is a collaborative document that assesses housing and community development needs of Ventura County and participating jurisdictions, analyzed housing markets and develops goals, strategies and priorities to address identified needs of the low to moderate income residents. The 2020-24 Regional Consolidated Plan will be the basis for the objectives of the City of Oxnard's 2020 Annual Action Plan, which will support addressing unmet needs of low to moderate income residents by funding specific activities, and the action plan activities through Plan year 2024.

HUD approved that the City of Oxnard participate in the five year 2020-2024 Ventura County Regional Consolidated Plan. The Plan results support development of six (6) goals for the City of Oxnard: 1) Create and preserve stable, safe, and resilient affordable housing opportunities for homeowners and renters including special needs groups such as farmworkers, persons with disabilities, and the elderly throughout Ventura County, 2) Enhance economic stability and prosperity by increasing economic opportunities for residents through job skills training and promotion of local entrepreneurship, 3) Increase access to health and wellness services, youth activities, senior activities, and social service activities for residents. 4) Work alongside the Ventura County Continuum of Care to end homelessness within Ventura County by providing housing, emergency shelter, and social services to homeless persons or those at risk of homelessness. 5) Enhance access to quality, resilient, and livable neighborhoods by improving publicly owned facilities and infrastructure such as parks, streets, sidewalks, and community buildings, including improving accessibility to meet Americans with Disabilities Act (ADA) standards. 6) Create and maintain effective housing and community development programs that address the priority needs listed within the Consolidated Plan, comply with all U.S. Housing and Urban Development (HUD) requirements, and achieve the goals and objectives set out by each Ventura County jurisdiction.

To receive annual allocations for each of the five years within the consolidated plan, an annual action plan will be prepared and submitted to HUD in June 2020 after City Council approval. This will be the 2020 Annual Action Plan, which will implement specific activities that meet the goals developed in the consolidated plan. The City of Oxnard received applications and community input as to the activities set forth in the 2020 Annual Action Plan. HUD 2020 program year allocations together with program income are resources that support \$2,644,388 for CDBG, \$876,135 for HOME and \$221,083 for HESG programs that benefit City of Oxnard's low to moderate income residents.

The City of Oxnard is required to submit to HUD an Analysis of Impediments to Fair Housing (AI). The City and the County of Ventura collaborated on the production of the AI, which covers the entirety of Ventura County. The draft AI presents a demographic profile of the County of Ventura, assesses the extent of fair housing issues among specific groups, and evaluates the availability of a range of housing choices for all residents. This report also analyzes the conditions in the private market and public sector that may limit the range of housing choices or impede a person's access to housing.
