### 2. **REPORT THE INJURY TO YOUR SUPERVISOR WHO WILL ASSIST YOU IN FILLING OUT A REPORT.**

If you are injured while working, you may be entitled to benefits under the California Workers' Compensation law including:

**MEDICAL CARE**—All authorized medical expenses are fully covered. If you need medical care, please go to one of the medical centers listed above. To change doctors, **call AIMS**. Should you still need care 30 days after reporting the injury and filing a claim, you may be treated by a physician of your own choice. NOTE: You may be treated by your personal physician immediately following your injury if you have notified the City of the name and address of that physician **and if that physician agrees in writing to treat workers' compensation claims prior to the injury**. For further information, contact the Human Resources Department at 805-385-7590.

**DISABILITY INCOME**—If you are hospitalized, or unable to work for more than 3 days, you will receive income equal to 2/3 of your average weekly pay, up to a legal maximum. If you have a permanent disability, additional payments may apply.

**SUPPLEMENTAL JOB DISPLACEMENT TRAINING**—If you have permanent disability, are in medical need for modified or alternative work as a result of your accepted injury and your employer is unable to offer modified or alternative work, you may be eligible for a training voucher.
