Mandatory Commercial Waste Recycling Waiver Application

The following California state laws require that organizations and multi-family units have recycling programs in place:

- [AB 341](#), organizations that generate four (4) yards of solid waste per week, or multi-family residential dwellings of five (5) units or more, regardless of the amount of commercial solid waste generated, are required to recycle.
- [SB 1383](#), all organizations are required to recycle organic waste.

A waiver is available for properties that meet certain criteria. Organizations that meet these criteria can complete this application to obtain a waiver from compliance. Staff will review the application, visit the site and determine if the waiver requested applies. Waivers must be recertified every two (2) years. Completed applications, with accompanying photographic support, should be sent to recycle@oxnard.org.

AB 341 - Mandatory Commercial Recycling Available Waivers

- De Minimis Waiver - generation of recyclable materials is less than 0.5 yds³ per week.
- Physical Space Waiver - adequate space to house containers on the premises does not exist. New construction is not eligible for this waiver.

SB 1383 - Short Lived Climate Pollutant Available Waivers

- De Minimis Waiver - where waste generation is two (2) yds³ per week, generation of organic materials is less than 20 gallons per week; where waste generation is less than two (2) yds³ per week, generation of organic materials is less than 10 gallons per week.
- Physical Space Waiver - adequate space to house containers on the premises does not exist. New construction is not eligible for this waiver.
