In any action or proceeding arising out of this agreement, the prevailing party shall be entitled to reasonable attorneys' fees and costs, including fees and costs of the Oxnard City Attorney Office. The water meter is the property of the City of Oxnard and only City staff may turn it on/off.

\*\*\*SB 1826- Organizations that generate 4 cubic yards or more of waste per week is required to recycle. Multiple-units of 5 or more units are required to recycle.
