HUD ENTITLEMENT GRANTS

The City of Oxnard, as an entitlement city, annually receives formula grants through the U.S. Department of Housing and Urban Development (HUD), Office of Community Planning and Development (CPD) Division through HUD CPD, the City receives Community Development Block Grant (CDBG), Hearth Emergency Solutions Grant (HESG) and HOME Investment Partnership Grant (HOME) funds. HUD entitlement grants are designed to principally benefit persons of low- and moderate-incomes, as defined in the HUD regulations. The City is dedicated to serving the diverse needs of its residents, and works to address the unmet needs identified through the City's community planning process and the use of these programs.

The procedural framework to receive entitlement grants is mandated in the HUD regulations wherein HUD requires grant recipients to set up a local process to encourage citizen participation. The City of Oxnard's entitlement grants planning process is defined in the <u>Citizen Participation Plan</u>. This plan sets forth the local procedures to receive citizen input regarding the needs and community service gaps that the programs may be able to address. The HUD regulations and local citizen plan requires that at least two public hearings, annually, to receive citizen input. The information collected through the public process assists in the City Council's decisions on how to spend program funds.

To receive the HUD entitlement grants, the City of Oxnard is required to develop a Five-Year Consolidated Plan and subsequent Annual Action Plans within the five-year period. The City of Oxnard participated in the <u>2020-24 Ventura County Regional Consolidated Plan</u>, wherein the City of Oxnard partnered with County of Ventura and the cities of Camarillo, Simi Valley, Thousand Oaks and Ventura. The City of Oxnard City Council approved the Regional Consolidated Plan on June 16, 2020.

The City of Oxnard must develop the 2023 Annual Action Plan that includes proposed activities for the forthcoming program year and must be submitted to HUD on or 45 days prior to the start of the new fiscal year. The goals described in the Regional Consolidated Plan serve as the parameters for prioritizing applications for program implementation within each program year.

NOTICE OF FUNDING AVAILABILITY

In program year 2022, the City of Oxnard received CDBG grant funding of \$2,365,280, HESG funding of \$211,474 and HOME funding of \$855,503. The City expects to receive HUD funding for program year 2023 that is similar to the amounts stated above. To accomplish the goals set forth in the City's Consolidated Plan and the objectives identified in the 2023 Annual Action Plan, the City will award grant funds to those projects that propose to meet the goals established in the regional consolidated plan. Funds are subject to change based on federal appropriations and any changes to the HUD grant allocation formulas.

CDBG and HESG Applications: The period to submit program applications for CDBG and HESG funding for program year 2023 will be from January 11, 2023 until February 13, 2023. 2020-24 REGIONAL VENTURA COUNTY CONSOLIDATED PLAN GOALS OVERVIEW

The Strategic Plan, located in the Regional Consolidated Plan (RCP), outlines each jurisdiction's plan for allocating HUD entitlement grants and identifies local priorities within the regional context. Informed by qualitative and quantitative data gathered through citizen participation and consultation with stakeholders throughout the region, market analysis, and an assessment of U.S. Census and other local data that reflect community needs, the Strategic Plan identifies the highest priority needs toward which to direct grant dollars. The following regional goals were identified to meet high-priority needs (in no particular order or ranking):

Goal 1: Create and preserve stable, safe, and resilient affordable housing opportunities for homeowners and renters including special needs groups such as farmworkers, persons with disabilities, and the elderly throughout Ventura County.

Goal 2: Enhance economic stability and prosperity by increasing economic opportunities for residents through job skills training and promotion of local entrepreneurship.

Goal 3: Increase access to health and wellness services, youth activities, senior activities, and social service activities for residents.

Goal 4: Work alongside the Ventura County Continuum of Care to end homelessness within Ventura County by providing housing, emergency shelter, and social services to homeless persons or those at risk of homelessness.

Goal 5: Enhance access to quality, resilient, and livable neighborhoods by improving publicly owned facilities and infrastructure such as parks, streets, sidewalks, and community buildings, including improving accessibility to meet Americans with Disabilities Act (ADA) standards.

Goal 6: Create and maintain effective housing and community development programs that address the priority needs listed within the Consolidated Plan, comply with all U.S. Housing and Urban Development (HUD) requirements, and achieve the goals and objectives set out by each Ventura County jurisdiction.

Grant funds are contingent upon submission of an approved Consolidated Plan and Annual Action Plan.

Hearth Emergency Solutions Grant (HESG) – The Hearth Emergency Solutions Grant Program provides funding to: (1) engage homeless individuals and families living on the street; (2) improve the number and quality of emergency shelters for homeless individuals and families; (3) help operate these shelters; (4) provide essential services to shelter residents, (5) rapidly re-house homeless individuals and families, and (6) prevent families and individuals from becoming homeless. <u>Click here to view more information from HUD HESG program.</u>
