### STANDARD CONDITIONS & FINDINGS

- 1. This permit is granted for the properties described in the application on file with the Planning Division, and may not be transferred from one property to another. (PL, G-1)
  - 2. This permit is granted for the plans approved \_\_\_\_\_ on file with the Planning Division and attached herein. The project plans shall conform to the plans, except as otherwise specified in these conditions. (PL, G-2)
  - 3. By commencing any activity related to the project or using any structure authorized by this permit, Permittee accepts all of the conditions and obligations imposed by this permit and waive any challenge to the validity of the conditions and obligations stated therein. (PL, G-5)
  - 4. This Minor Modification shall automatically become null and void on \_\_\_\_\_, unless Applicant has diligently developed the proposed project, as shown by the issuance of a grading, foundation, or building permit and the construction of substantial improvements. (PL, G-3)
  - 5. Permittee agrees, as a condition of approval, at Permittee's own expense, to indemnify, defend and hold harmless the City and its agents, officers and employees from and against any claim, action or proceeding to attack, review, set aside, void or annul the approval of this permit or any condition attached thereto or any proceedings, acts or determinations taken, done or made prior to the approval of such permit that were part of the approval process. Permittee's commencement of construction or operations pursuant to this approval shall be deemed to be an acceptance of all conditions thereof. (CA, G-6)
  - 6. Before placing or constructing any signs on the project property, Developer shall obtain a sign permit from the City. Except as provided in the sign permit, Developer may not change any signs on the project property. (PL/B, G-10)
  - 7. Developer shall obtain a building permit for any new construction or modifications to structures, including interior modifications, authorized by this permit. (B, G-11)
  - 8. Prior to issuance of building permits, Developer shall pay a document imaging fee for the planning files in an amount calculated by planning staff at the time of building permit review based on fees then in effect. (PL/B, PL-16).
  - 9. After completion of construction and prior to the final inspection being conducted, the site must comply with Oxnard Municipal Ordinance 2372 (Solid Waste Ordinance).
  - 10. Except as modified by this request, all permit conditions of \_\_\_\_\_ shall remain in full force and effect.
